AS THE ADOPTER, I AGREE TO THE FOLLOWING PROVISIONS:

1. If the Adopted Animal is not already altered, I agree to have the Adopted Animal altered by this date: _____
I understand and agree that the adoption is not final and the Animal Network remains the owner of the Adopted Animal until the spay/neuter surgery is completed. (Initial): _____
2. I agree to keep an identification tag attached to a properly fitted collar that will remain on the Adopted Animal at all times and to obtain all city licenses required by local authorities. I agree to keep any contact information up to date with the microchip registration company. Animal Network will complete the initial transfer with the information from this contract.
3. I agree to provide the Adopted Animal with regular veterinary care.
4. I agree to have the Adopted Animal under my control when he/she is not within the confines of my property. A secure fenced area will be provided for dogs, including shelter from the elements. If the Adopted Animal is a cat, I agree to keep the cat as an indoor-only pet and I pledge never to declaw the animal under any circumstances. The Adopted Animal will not be tied or chained.
5. If for any reason I cannot keep the adopted animal, I agree to notify the Animal Network of the availability of the animal, and to allow them adequate time to help me facilitate finding the animal boarding or a new home. I will never take the animal to a shelter and will not re-home the animal without consent of the Animal Network. Adoption fees were paid as a "pay it forward" donation after two weeks of adoptions but we will always take back our animals no matter the time in the home.
6. I agree not to abuse or neglect the Adopted Animal and I authorize the Animal Network, at their sole discretion, to determine whether or not the Adopted Animal has been abused or neglected.
7. I understand that the Adopted Animal covered by this adoption contract is, as far as can be determined by the Animal Network, in good health and that the Animal Network is not responsible for any medical fees incurred after the adoption date. However, if a health problem develops during the first 10 days, I should notify the Animal Network so we may discuss the matter.
8. I agree to give the Animal Network visitation rights to ensure that the terms of this adoption agreement are being observed.
9. I understand that any failure to perform the foregoing agreement will constitute a breach of contract. In the event of any such breach of contract, I authorize the Animal Network to reclaim both possession and ownership of the Adopted Animal. I also understand that the Animal Network is not liable to me or any other party for any losses, injuries, damages, costs, expenses, lawsuits or judgments whatsoever in connection with my adoption of this animal.
